



NOTICE OF THE FIRST INTERNATIONAL COMPOSITION COMPETITION

Festival dei Cammini di Francesco - 2023 Edition

The theme of the Festival:

"Rule, autonomy and freedom"

The 2023 edition of the Festival dei Cammini di Francesco draws inspiration from the 800th anniversary of Franciscan Rule, focusing on the role of rules and their relationship with individual autonomy and freedoms in the various domains of knowledge and social development. The achievement of freedom is closely linked to the concept of autonomy. This, in turn, is only attainable if one acts within the scope of rules designed to protect oneself, others and the environment.

The Progetto Valtiberina Foundation is organising The First International Composition Competition as part of the Festival dei Cammini di Francesco 2023 edition "*Rule, autonomy and freedom''*.

REGULATION

- **ART. 1.** The competition is open to composers of all nationalities, without age restrictions.
- **ART. 2.** Each candidate may submit one or more entries for:
 - **A)** CLARINET (and/or Bass Clarinet), VIOLIN, CELLO And PERCUSSION (Vibraphone, Glokenspiel, Crotales, Tom-tom drums, Suspended cymbals and Wood Block)
 - B) CLARINET (and/or Bass Clarinet) VIOLIN and CELLO
 - C) CLARINET (and/or Bass Clarinet) and VIOLIN DUET
 - D) CLARINET (and/or Bass Clarinet) and CELLO DUET
 - E) CLARINET ONLY (and/or Bass Clarinet only)









- **ART. 3.** Each composition should not exceed 10 minutes.
- **ART. 4.** It is possible to submit compositions already performed as long as **they have not been awarded prizes in** other competitions (under penalty of exclusion from the competition).
- **ART. 5.** Composers must send their score in PDF format to the following email address: fondazione@progettovaltiberina.com with artistic direction on copy: giovani.armonie22@gmail.com. The subject of the email should be: First International Composition Competition of the Festival di Cammini di Francesco. The score must be anonymous as well as free of any signs or references that could be used to identify the composer. An *abbreviation* or *motto* will be added to the score as well as the entry form, so that it can be traced back to the composer once the jury has concluded its review;

ART. 6. Along with the score you must send:

- the name and contact details of the composer (name, surname, date of birth, nationality, address, telephone number, email).
- a short resume.
- receipt of the participation fee payment, including in electronic format.
- a declaration that the composition has not been awarded a prize in any other competitions and a photocopy of an identity document.
- The documentation can be written in either Italian or English.
- **ART. 7.** It is advisable, but not mandatory, to include a link to an audio recording or computer simulation.
- ART. 8. Scores must be sent by midnight, 12th May, 2023.
- **ART. 9.** A participation fee of € **70.00 for each score**, must be paid to C/C bank account no. 4211721P; BIC BPMOIT22XXX; IBAN code IT79P0538771610000042117219 at BPER Banca, payable to Progetto Valtiberina. Reason: "Participation in the First International Composition Competition Festival di Cammini di Francesco 2023 edition" must be stated on the attestation; the participation fee will not be reimbursed under any circumstances.
- **ART. 10.** The Jury will be chaired by Maestro Fabrizio De Rossi Re (President of the Jury).





ART. 11. Besides the winner's composition, the best selected compositions will be performed by the Contemporary Ensemble 'Giovani Armonie' in one of the concerts scheduled during the event. This will be on a date to be determined, at which the awards ceremony will take place at the same time.

- The Progetto Valtiberina Foundation will award the composer of the winning work (the first prize winner) a €300,00. scholarship.
- The winning compositions will be published by AGENDA of ERICA SALBEGO publishing house located in Bologna which will also disseminate them on institutional websites and on some digital platforms.

ART. 12. The jury reserves the right not to award prizes to any of the scores received, to award ex-aequo prizes or to single out particularly meritorious compositions. The Italian version of the notice shall prevail.

ART. 13. This notice is published in Italian and in English; in case of dispute the only legally valid text is the original text in Italian and the competent court is that of Arezzo.

DATA PROCESSING AND TERMS OF THE REGULATION

Data processing: The Fondazione Progetto Valtiberina and the Cammini di Francesco Festival 2023 edition are responsible for the processing of your data, which will be treated confidentially and with respect for your rights. Pursuant to Art. 13 of Legislative Decree 193/03, the data provided will be processed for organisational, logistical and promotional purposes. By submitting the application form, each participant in the competition authorises the organising foundation to use photographs and video recordings of performances exclusively for the promotion of the festival, the foundation or the individual participants, who acknowledge that this form of use will not entitle them to any remuneration.
